Definition of Voting Member and Social Member (RE: Article Two, Members, of the Lake Athens Property Owners Association, Inc. Bylaws):

2.05 Eligibility for Membership.

- a. Voting Member. Any lake area property owner who is required to pay ingress and egress fees directly to Athens Municipal Water Authority (AMWA) (commonly known as a lakefront property owner) is eligible for membership in the Lake Athens Property Owners Association as a Voting Member. This level of membership includes the right to vote in Board of Director elections and any other matters brought before the membership, as well as to serve on the Board of Directors.
- b. Social Member. Any lake area property owner who is not required to pay ingress and egress fees to AMWA (commonly known as a non-lakefront property owner) is eligible for membership in the Lake Athens Property Owners Association as a Social Member. This level of membership includes all the benefits and privileges of membership in the Association, with the exception of the voting rights and ability to serve on the Board of Directors outlined in paragraph 2.05a, above.
